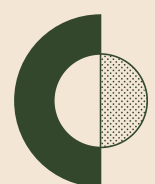

TERMS & CONDITIONS

1. Registration and Ownership The vehicle will be registered under Europe Roadtrip Company's name for the duration of the registration contract. However, all liabilities, responsibilities, and obligations related to the vehicle, including legal, financial, and operational matters, remain solely with the customer who purchased the vehicle. The customer is considered the beneficial owner and is liable for any damage, fees, fines, or legal issues involving the vehicle.

2. Annual Fees and Notice Periods

- Annual Fee: The customer is required to pay an annual fee for the registration and management of the vehicle under this program. This fee covers the administrative and logistical services provided by Europe Roadtrip Company.
- Notice for Termination: Both Europe Roadtrip Company and the customer have the right to terminate the registration contract with a minimum of 6 months' written notice. In such cases, a maximum of 6 months' pro-rated refund of the annual fee may be provided if the fee has been paid in advance and the customer has not used services beyond this period.

3. Road Tax, Insurance, and Registration Fees

- Ongoing Payment: Road tax, insurance, and any additional registration fees are to be paid by the customer in full for each year, regardless of whether the vehicle is actively used. All such payments are required upfront at the start of each contractual year.
- Continuous Coverage: Even if the vehicle is stored or unused for a period, the insurance and registration must remain active, with all related fees covered by the customer to ensure ongoing legal compliance and avoid penalties.

4. Security Bond

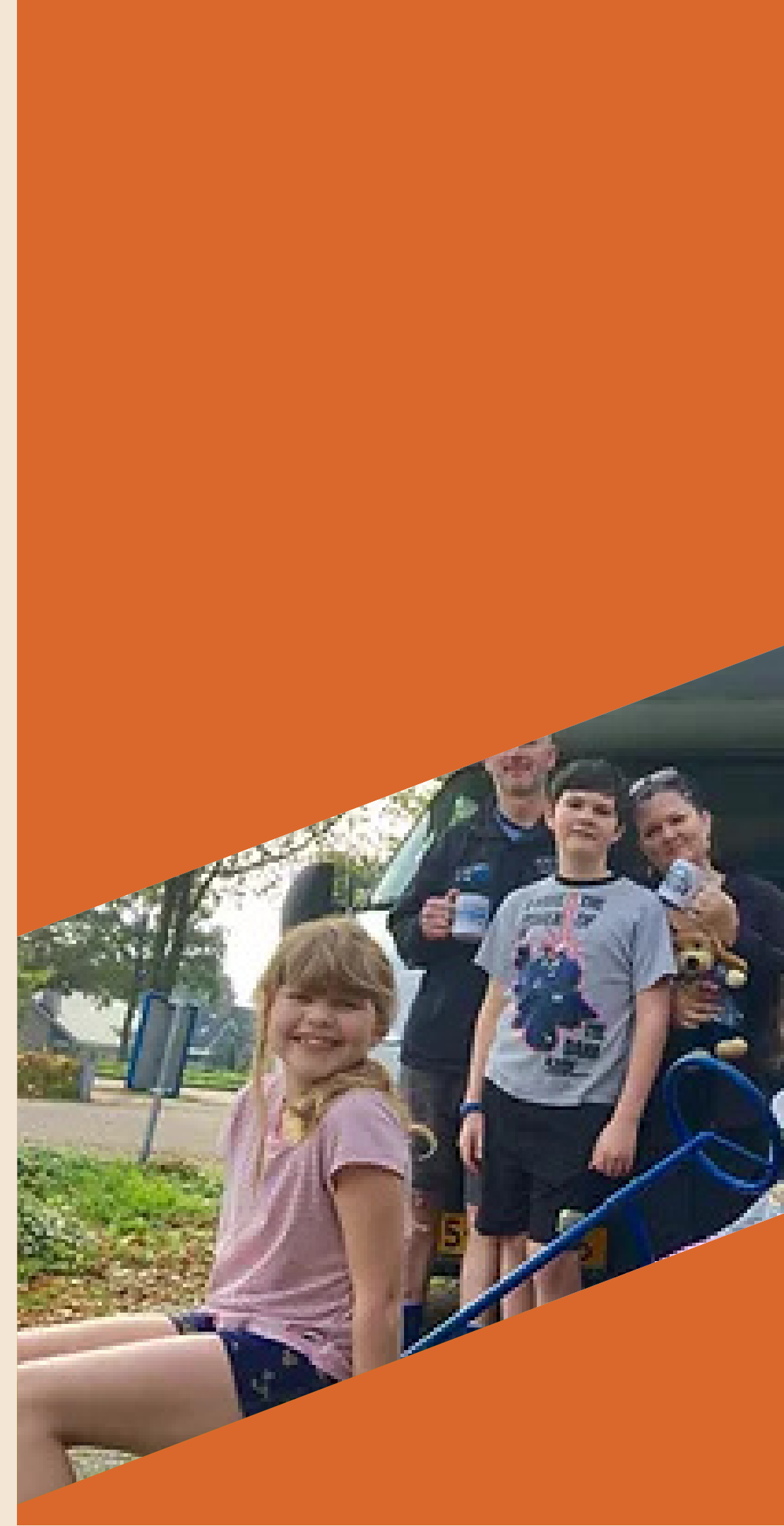
- Bond Requirement: A refundable security bond of €1,000 is required from the customer at the beginning of the contract.
- Usage of Bond: This bond may be used by Europe Roadtrip Company to cover emergency expenses, damages, fines, or other unanticipated costs associated with the vehicle if the customer cannot be reached or is unable to make immediate payments.
- Refund of Bond: If the bond is not used during the contract period, it will be fully refunded to the customer upon termination of the contract, once all outstanding fees, fines, and liabilities have been settled.

5. Liability

- By entering this contract, the customer agrees that they are fully responsible and liable for the vehicle under all circumstances. Any expenses, fines, damages, or legal liabilities incurred as a result of using the vehicle will be borne entirely by the customer. Europe Roadtrip Company assumes no liability beyond the administrative services rendered for vehicle registration, insurance arrangement, and consulting support.

6. Agreement to Terms

- By signing this contract, the customer acknowledges and agrees to all terms and conditions outlined above, including payment schedules, liability responsibilities, bond requirements, and notice periods.
